Westport Light State Park – Westport Golf LLC Proposal Comments

July 6, 2023 – October 23, 2023

To whom it may concern,

I am a Westport resident opposed to the golf course for the following reasons: After reviewing this hydrology report: Hydrologic Report (wa.gov) it is clear that Westport's drinking water system is vulnerable to fertilizer use and salinity intrusion associated with the golf course. Figure 5-11 in the hydrology report shows that Westport's North Well Field is at risk of fertilizer intrusion.

The report explains there are 89.25 acres of fairways and greens that will require fertilizer. Every 1000 square feet of greens will receive 8 lbs of nitrogen, 4 lbs of phosphorus and 6 lbs of potassium per year. The report does not explain how much fertilizer is required by the fairways, but if we assume the same amount, that would require 86,000 lbs of fertilizer per year. That is about 100 ford f-150s truck beds filled to capacity with fertilizer every year dumped on the golf course. AECOM's study, funded by the state, has shown this fertilizer could reach Westport's North Well Field (see figure above). The second point I want to make is the following quote from taken directly from the report, "Overall, no risk of saltwater intrusion is anticipated based on the numerical modeling results. The only potential for saltwater intrusion could be related to increased pumping of the North Well Field, if this well field is used to supply irrigation water for the golf course. However, the ultimate source of irrigation water is not known at this time; thus, no changes to the wellfield pumping rates were incorporated into AECOM's study." Since the water irrigation source could be the North Well Field, the project is again putting Westport's drinking water at risk. Also, my neighbor told me that Grayland already has saltwater intrusion because their water table is so low.

Finally, in 2014, Washington residents took an estimated 4.1 million trips to the Washington coast, with nearly 60 percent indicating their primary purpose was recreation. The top five activities respondents participated in on their last trip were beach going (60.5 percent), sightseeing or scenic enjoyment (57.1 percent), wildlife viewing (35.1 percent), photography (34.3 percent), and hiking or biking (28 percent). Of all the recreational uses listed, golf did not make the list for main activities, and was only listed by a portion of respondents as part of an "other" category, which was approximately 3% of respondents. A potential explanation of this could be that there aren't many golf courses on the Washington coast, however, another potential reason is participation in golf has been declining in recent years around the country as younger generations haven't had the same level of interest as previous generations. Additionally, the closure of golf courses around the country has been happening at an increased rate in recent years. Furthermore, there are already golf courses in Ocean Shores, Surfside, Ocean Park and Long Beach, which are all within 1.5 hours of the proposed Westport course. In light of this data on the most popular recreational uses and trends for the sport of golf, it seems like it might be putting the cart before the horse in moving forward with the development of a golf course for this public space.

In light of a national trend towards the privatization of our public lands, we need to remember that this property was purchased with 1.9 million publicly funded dollars via the Recreation and Conservation Office 10 years ago. The proponents of golf development could've previously purchased it with their own money. Any partnership, or potential new use for this newly acquired public land needs to ensure

that there is equitable and affordable access to all park visitors, and not creating barriers for those who are less privileged or restrictions on access and potential user conflicts. As stewards of these coastal lands, you must ensure that whatever decisions you make are in line with the public interest and the greatest benefit for a diverse set of recreational uses and users, not catering to special interests of a select few. ¹

We purchased property in Grayland 15 years ago, in part because we believed that the golf course

From an economic standpoint there is an urgent need for businesses and amenities that will attract affluent and younger people to the region regularly. The business community believes that a golf

course is the highest and best use of this community property. Though I have not researched the economic impact of golf courses to remote towns, I want to believe that the business community is correct so that this project moves forward to bring economic vitality back to this part of the world.

I am not a golfer. I suspect that locals would not utilize the course due to the sport being costly and requiring experience and/or training. I would wish that locals are able to obtain season golf passes at much discounted rates so that they could enjoy this specialized use of this community property.

I am supportive of a small, tasteful golf course being constructed, with the bulk of the pristine land being used for other activities that are less expensive to create and maintain and that tread more lightly on the environment. Two ideas are a mountain biking course and disc golf. These other uses would enhance the odds that residents, particularly young residents, in the area will regularly utilize this wonderful real estate.²¹

I would like to voice my strong support for the Westport Light State Park Golf Links. As a current city of Westport homeowner since 2010 and prior having family-owned property in North Cove since the early 1970's, I have enjoyed the many spoils of this amazing seaside environment. I believe if done correctly in a low-impact manner, the proposed golf course would enhance previously degraded areas, help to preserve, and possibly expand existing species of native plants and provide a much-needed economic boost to Westport and the surrounding communities.

My only request would be assure there is clear understanding and consideration of "local" socioeconomic factors and make allowances that provide affordable access to the golf course for the local residents.²²

I would like to express my full support for the golf course project in Westport Light State Park. I am a homeowner in Grayland and consider the project to be of unique and certain benefit to the local area. Westport has a rich history, mostly around the fishing and logging industries. While the golf course project will not recapture the vibrant economy of 50 years ago, it would be a significant boon to the area, directly offering jobs in development and operations, and act as a magnet for other businesses and a support for others already here and struggling to be successful.

I personally enjoy golf, and the managed landscaping oriented towards native species would actually improve the local ecology. Not native species have become a significant blight and the park area slated for the golf course project could eradicate a concentration of that blight. The wider area is also home to two other large State Parks for campers, birders and beachcombers to enjoy. The Westport Light Park has become a dangerous area for fire hazard and offers little access to the public. The community will benefit from the new trails and recreational areas planned, as will indigenous wildlife and plant species.

I have discussed the plusses and minuses of this development with a number of others who live in the area and vacation here. Nothing about the land represents the original native environment. We are one of a few tourist businesses on the South Beach that are open daily, year around. This experience provides us the unique perspective of listening to visitors about what they hope to find in their trips to the area along with regular communication with our neighbors in their vision for the future. We are fully committed to providing both jobs and services to our community and view this project as a positive move for others to join our proven track record of success.

Over the years we have met with numerous groups and individuals who say they want to do what we do, but only in the summer. This is not a sustainable business model, nor is it beneficial in creating a vibrant and stable local economy. The key to our success, in addition to great products and service, is availability. We see this as a viable proposal and one that has the potential to add significant impetus to local economic success because it does not rely solely upon summer activity. citizens and visitors to Grays Harbor County and the City of Westport would benefit from this proposal. Westport, already a beach destination, is the best site to offer this type of public private partnership. We believe this project would provide year around living wage jobs, important recreational access to public lands, and an environmentally respectful recreational experience to a variety of users.

Currently, the property is a blight, with extensive invasive weeds, a high fire hazard, an absence of accessibility, and a reputation of unsafe and unsanitary transient camping. All of these problems could be addressed with the approval of this project and creation of a links golf course. As long-time residents of Lahaina, Maui, we understand better than most the potential and likely threat of wildfire in an isolated community. Everything we once owned in Hawaii is gone. A project like the golf course would result in greater access, fire fuel reduction, and increased response ability by local firefighters in this area.

There is already an abundance of wildlife on the property and within Westport city limits. It is unlikely that the development of this property would negatively impact those populations that have already found adaptations to the suburban interface. It would however create opportunity for better management and viewing for all ages and levels of mobility.

The proposal includes development of lodging. While there are a variety of excellent places for visitors to stay in Westport, there are few oceanfront options that are so often requested by our guests even though we offer lodging on our property already. We have excellent relationships with those in the lodging business and appreciate all their positive efforts in providing places for our visitors to stay, however, there is more demand than supply in this market segment.

Westport is the primary commercial and recreational fishing port on the Washington coast. This community relies upon the sustainable harvest and marketing of natural resources. Any effort to bring more people to our harbor to see the value of this industry, the rich cultural significance of our lifestyle, and a glimpse of the hard work needed to provide food for the world is a significant side benefit of this project.

This development of the Westport Light State Park could indeed be the long-awaited tipping point for our community. While we don't know them, we welcome these investors. We encourage State Parks to embrace this partnership for the benefit of the land, the local citizenry, and visitors to the state. We look forward to the enhanced lifestyle and recreational opportunities this will bring to our very special beachfront community.²⁴

The project as proposed would make significant changes to the amount of overgrowth and help to eradicate the fire risk posed by scotch broom and downed shore pine. Plans that I have seen appear to also prioritize, protecting wetlands and increasing access to the park for those of us with handicaps. These are all good things for the City of Westport. My family uses this park every day and we are fully in support of the golf links project. ⁴² I want to express my support for the proposed Scottish Links Golf Course. I have reviewed their detailed plans and find them very environmentally friendly and their site plans will do a lot to improve the accessibility of this area to everyone. Dear Washington State Parks Commissioners,

I'm a life-long resident of Grays Harbor, growing up on a cranberry bog between Hoquiam and Ocean Shores, and working as an investment advisor in Aberdeen for 41 years. For full disclosure, I am an avid golfer and a small investor in Westport Golf Links, LLC.

In the 1960's and early 1970's Grays Harbor was a booming economy, with logging, wood products, fishing, and tourism as the leading industries. The economy abruptly changed in the late 70's and early 80's. The Boldt decision took a thriving fishing business and "gutted" it permanently. Westport's economy became a sad comparison to its pre-Boldt status. In logging and wood products the spotted owl ruling "undercut" a thriving industry. The logging industry here has never been the same. Generally, the tourism business has continued to do well, except in Westport which relied so much on fishing.

For years, anytime there was a news report on events in the area, we've been referred to by the media as "economically depressed Grays Harbor". Quite often the government has handed out grants for projects here that have been welcome "band-aids", but nothing that changed economic conditions here.

The Washington State Parks Commission now has the opportunity to bring the first new industry to Grays Harbor (other than the Stafford Creek Prison) in many years. The location of the Westport Golf Links in Westport is especially appropriate considering the problems that its fishing business has experienced. Westport, and all of Grays Harbor, desperately needs the influx of golfers and vacationers that the course will create. The "multiplier effect" will lift up businesses including lodging, restaurants, gift shops and even the fishing business. These opportunities don't come along very often.

Let's not ignore ecological considerations. Using the Westport treated wastewater on the golf course rather than pumping it into the ocean is a major improvement. Low wetland areas will be avoided in golf course construction and use. I've heard that there is a plan to reintroduce endangered plant species on unused land. Another factor is that the "native" dunes areas to be used, are not necessarily "native". The Westport Museum has some very old pictures showing no vegetation at all on the land west of the lighthouse. The photos show sand only, no grass, bushes, or pine trees. I hope the commissioners get a chance to view these photos to see what the "native" beach was like back then.

In summary, I appreciate the time you spend as commissioners and hope you see fit to make a decision that will help so many Grays Harbor and Westport residents.⁴⁵

Greetings,

I attended via Zoom the October 18, 2023 Parks Commissioners study session in which a review of the Westport Light Golf Links was presented by proponents. I would like to address some of the statements made at that study session. Proponents claimed that the development of the golf links would be

environmentally beneficial to the park. They relied on the fact that shore pines and scotch broom would be controlled. This simplistic attachment to two species of plants does not represent an environmental gain. What about the use of fertilizer and pesticides? What about the potential for salt water intrusion from the high use of water in dry months? Evaluating critical areas is a complex endeavor as evidenced by the numerous environmental reports produced by Parks for this development.

Once again, proponents make statements that are based on opinions with narrow viewpoints. They are entitled to have their own perspective, but it doesn't make their statements worthy of consideration other than as those of developers trying to make a deal, in my view.

Gray's Harbor County takes environmental protection of sensitive habitats seriously. I would reference Title 18 Environment, Chapter 18.06 Critical Areas Protection Ordinance: http://graysharborcowa.

Also of note during the presentation was that proponents indicated that only 20+ acres of wetlands would be disturbed, but that those could be created on site and elsewhere. What about the wetland buffers of 110 feet?

I am aware of the wetland buffer issue when developing property. My own home in Grayland, a 7000 square foot lot, required a Reasonable Use Exemption because my lot was within 110 feet buffer of a wetland. To be clear, I was not displacing any wetland, I was within 110 feet of the wetland.

Yet proponents did not discuss wetland buffers at all. Have those aspects disappeared for the developer?

I was required to gift 1100 square feet of my lot to Grays Harbor County as a Conservation Easement in perpetuity. I can't use that land going forward. I was not offered off-site mitigation.

And yet, proponents of the golf course seem to feel they can develop wetlands on and off-site for mitigation, including another state park, to offset use of the wetlands and buffer areas. I will take exception to this if the golf course is approved and will be contacting the County to find out how to complain about separate treatment regarding critical areas. The proponents mentioned the potential for "reintroducing Snowy Plover habitat" which is not at all based on the habitat needs of these birds.

I am glad a Parks staff member was there to provide some factual comments to contradict some of the statements made by proponents. The dune trail may have returned to its original position in the updated plan, where it is located now, but it still weaves among and next to golf links. They displayed a photo of a section of the trail at Chambers Bay Golf Links in University Place as a comparison and indicated that there had been no golf strikes of pedestrians to date. While this may be true, I can't verify it, it doesn't mean the potential for golf ball strikes isn't possible.

My parents owned a home on a golf course for a short period of time. When I visited for a weekend, golf balls routinely hit the roof of their home. We didn't sit in the back yard at all for fear of strikes. Golf ball strikes, or the fear of them, is going to alter use of the dune

trail and perhaps the beach as well. Will people simply feel they must stop using Westport Light State Park?

I'm not an expert, but all you have to do is a Google search for "golf ball strikes pedestrians" and many items come up for review. This article, "Club may be liable if stray golf balls hit walkers on new trail, city warns" from 2021, talks about the problem. Solutions were to erect high nets and require golfers to only use certain types of clubs. Some of the most common injuries associated with golf ball strikes are traumatic brain injury, skull and facial fractures.

Another article "Golf balls are flying in Scottsdale, and green belt users are concerned about injuries, safety" 2019. The article describes how a walker interviewed said "He is constantly aware when golfers are on the tee." He speeds up to get down the path faster, but was still hit by an errant ball.

The article describes how this is a high use trail. They concluded that "It appears that the risk of injury for any one user is not great," the report read. "However, the risk does exist."

Another runner on the path interviewed said "Every time I run that path I think, 'Is somebody going to hit me with a golf ball?' "

Scottsdale erected signage to indicate areas of stray golf balls.

The article goes on to say that, generally speaking, there is going to be a risk of errant golf shots around any golf course and that signage is insufficient remediation. Parks will certainly be forced to erect signs in the park, parking lots, beach and dune trail, warning pedestrians of the danger of ball strikes. What will be the result? Maybe there will never be a ball strike. Maybe pedestrians will learn to be vigilant and "keep an eye out" for stray balls. An example of a sign to erect might be: "Pedestrians watch for golf balls which can cause injury." or "Pedestrians walk at your own risk." I mean seriously, how is this a park experience that is good for anyone? The proponents presentation still included the consultant review of regional fiscal benefits. Has this been confirmed? They indicated local jobs would be plentiful in the pro shop, maintenance of the course and hotel. In my view, maintenance leadership roles will be highly specialized and those employees will move to the area, not be hired from the area. Hospitality work will be available in restaurant and hotel housekeeping. But this is hard work with notoriously low wages and no benefits. Construction jobs will come and then go with no guarantee that they will be locally sourced. They, and the outgoing Commissioner, discussed in some detail how Grays Harbor County has a higher unemployment rate than the average in the State. They indicated that this is a chronic condition that is the result of many factors including The Great Recession of 2008. While everyone suffered during the Great Recession and many other fiscal events, there is nothing unusual about higher unemployment rates in rural counties. Rural counties as a group have consistently higher unemployment rates than urban counties. In March, 2015, Grays Harbor unemployment rate was 9.4%, Kittitas County was 6.3%, Grant County was 8%, and Ferry County still the highest with 11.7%. King County was 4% and Pierce 6.5%. Further back in July 2001. Grays Harbor County was 8.6% and King County 4.9%. See Employment Security Department Washington State Monthly employment report: https://esd.wa.gov/labormarketinfo/monthlyemploymentreport If you investigate further on the Employment Security Department of Washington State website, you will find more details. Current unemployment for Grays Harbor for August 2023 is 5.5%. Kittitas County is 5.1%. Urban counties like King and Pierce are 3.7% and 4.4% respectively. Ferry County in the northeast section of the state had 7.1%. These are exceptionally good numbers for the county, although still not as low as the urban counties. See Office of Financial Management State of Washington for 2022 https://ofm.wa.gov/tags/county-data. Again, rural counties have higher unemployment than those densely populated. Yes, fiscal shocks happen and it hurts everyone, but the fact remains that the state unemployment rate averages are always lower than the specific unemployment rates for rural counties. It's just the nature of rural vs urban. To consistently highlight Grays Harbor County employment rates, while not comparing them to other rural counties, is selecting data without comparable comparisons. Presenting unemployment data and fiscal analysis from a narrow perspective gives the impression that the proponent evaluations and solutions are valid and reasonable. of which I strongly disagree.

What about poverty rates? If you talk about unemployment, I think

poverty should be incorporated into the discussion. Currently, Grays Harbor rates are 14.3-24.7% and Kittitas County is the same. King and Pierce are 7.3-9.7% respectively. Do you see the similarities? The poverty rates mimic the unemployment statistics. This also makes sense: rural counties have more poverty than urban counties. I think we can agree that poverty and unemployment are serious issues. Addressing them requires a complex understanding of many aspects of life in Westport and the County. Unemployment, types of employment, infrastructure and housing are just some of the aspects to study.

What is assured, is that gentrification will happen. Housing prices will rise, as will rents. Grays Harbor County seems to hand out short term rental approvals readily. The County will have to, at some point, develop an abiding concern about housing residents who live and work here as well. Currently the County wait list for the limited low-income housing units available is closed. Applicants can't even get on the wait list. These are all serious issues that will need to be understood. Where are those studies?

People love rural areas specifically because they are not urban. How will a championship golf course affect the region? What, exactly, will the region become? A study on comparable locations with golf courses installed would be something else to consider.

Again, Chambers Bay Golf Course was created by a lauded designer, holds championship events, and since its installation in 2008, has never made a profit. All this while being located in the south Puget Sound region with over 4 million people within an hour of the course. A study of the financial success of golf courses might be informative. I expect, and am grateful to, Parks staff for being vigilant in the preservation of critical areas and maintaining our state lands for everyone to use. I am impressed by the reports from staff and their dedication to science and facts. We have the best parks in the country thanks to staff who do exceptional work, and in policies that keep our state parks as wild as possible.
