

# Capital and Operating Budgets


As of January 2024 | FM07 | 29.1% through biennial cycle




### \$39.3 Million Collected in Revenue



#### Comparing fiscal year-to-date revenue



# Calendar Year 2019-2023 Earned Revenue and Visitation





  - Session scheduled for 60 days to March 7, 2024
  - Enacted budgets expected no later than March 29
- 2025-27 Budget Development
  - ELT currently reviewing submitted decision package ides
  - Commission reviews initial draft in May 2024
  - Agency request approved by Commission in July 2024
